- 1. Your tendered amount of \$3,932,818.95 plus GST \$393,281.90 for the total amount of \$4,326,100.85.
- 2. Post tender adjustments to the tender amount as agreed:
 - a. Deletion of gravel and asphalt members car park;
 - b. Deletion of concrete kerb from track drainage swale;
 - c. Deletion of concrete path from behind the members and administration building;
 - d. Deletion of watermain & Council connection;
 - e. Deletion of exercise ring adjacent to mounting yard;
 - f. Deletion of track access path for training;
 - g. Reduction to clearing due to changes to track geometry;
