Race Information Legislation

Race Information Subcommittee

Resolution:

That the "committee" consisting of Tony Hanmer, Malcolm Tuttle, Shara Murray and Adam Carter are authorised by the Board to negotiate a commercial outcome with all wagering operators for the payment of fees for the use of race information for the purpose of race wagering based on the model proposed for post October 1, 2010. The period to be negotiated is from September 1, 2008 up to and including September 30, 2010.

That the 'committee' are authorised by the Board, subsequent to any commercial agreement being negotiated, to enter into a legally binding deed with wagering operators.

The Board agrees that it will ratify the deed at a subsequent Board meeting."

3. Thoroughbred Horse Racing Industry Board Game

Ms Murray updated the Board in relation to a request from Ray and Gwenda Richards to use the name "Stradbroke Handicap" name in their board game they are developing.

The Board **AGREED** to the use of the "Stradbroke Handicap", however, approval should be sought from the Brisbane Racing Club.

Ms Murray to write to each party advising them of the Board's decision in relation to this matter.

4. The Oakley Amateur Picnic Race Club

Ms Murray updated the Board in relation to the Oakley Amateur Picnic Race Club's (Club) request concerning the procedure required should their Club decide to de-register as a registered/licensed race Club, but, continue as an Association.

Ms Murray sought the Board's approval for the following procedures when a Club relinquishes its race Club licence and the following procedure be inserted into Racing Queensland's section 81 (i) policy *Policy on the Formation, Management and Licensing of Clubs*:

- (a) The Club is to formally advise Racing Queensland in writing that it wishes to relinquish its race Club license. This formal notification is to include the date it intends to relinquish its license, a copy of the Member's Minutes approving this relinquishment and the Club's intentions in relation to further operations of the Association/Corporation.
- (b) The Club to be advised in writing by Racing Queensland that:
- The Club's license has been relinquished [as at the relevant date]
- ii. The Club will no longer be covered by Racing Queensland's public liability insurance and/or other relevant insurance coverage
- iii. The Club will not be allocated any race dates
- iv. The Club will not receive any funding from Racing Queensland, and

v. Under the Australian Rules, if participants take part in an unregistered meeting they are disqualified as are their horses. [This occurs unless Racing Queensland gives dispensation – Racing Queensland would be inclined to give dispensation as long as the Club advises the licensee they are not insured etc.]

The above procedures were **APPROVED** by the Board. The Board also **APPROVED** that such procedure be inserted into Racing Queensland's *Policy on the Formation, Management and Licensing of Clubs*.

5. Cairns Greyhound Racing Club Inc

In light of the Policy on the Formation, Management and Licensing of Clubs, Ms Murray advised the Board that a written formal request had been received from Ms Emma Bryant (formerly O'Connor), President of the Cairns Greyhound Racing Club Inc. (Club) seeking permission from RQL to allow licensees as members of the Club's Committee

The current Club Committee is comprised of:

Emma Bryant – Licensed Trainer – President / Honorary Secretary Bev Vandine – Licensed Trainer – Treasurer Gregory Manski – Licensed Attendant – Committee Member Arthur Gosper – Licensed Trainer – Committee Member Jeffery Down – Licensed Bookmaker – Committee Member, and Peter Kennedy – Non Licensee – Committee Member.

The Board RESOLVED that:

- (a) the Cairns Greyhound Racing Club Inc to have more than two (2) licensees as Club Committee Members, and
- (b) the Cairns Greyhound Racing Club Inc to have a licensee hold the position of race club secretary.

2.3 Finance Report

Mr Adam Carter updated the Board in relation to the management accounts for year end for 30 June 2010, month 31 July 2010 and the proposed draft FY1011 budget Version 1.

- Thoroughbred Surplus \$4.557M
- Harness Deficit \$684K

- Greyhounds Deficit \$858K
- Joint Venture Deficit \$400K

Mr Carter sought the Board's approval for the following:

 For the Board to note the finance report for June 2010 with the final audited annual financial statements to be reviewed by the Audit, Finance and Risk committee with the auditors BDO Kendalls after the 9 September 2010 and to be sent by flying minute to be approved by the Board.

2. For the Board to note the finance report for July 2010.

- For the Board to adopt the Budget Vs1 budget for FY1011 and to adopt the following recommendations:
 - (a) Approve the assumptions
 - (b) Approve the options below:
 - (i) To confirm no incentive component to Harness clubs as per the licence agreement of \$100K p/a.
 - (ii) Remove the top-up of 4.9% on course turnover payment to greyhound clubs RQL to retain
 - (iii) Remove the 0.05% off course payment to greyhound clubs RQL to retain
 - (iv) This is estimated to be \$600K per annum and in taking into consideration point 2 and 3 above a review of an operational subsidy required to the Greyhound Clubs to cover operational/administration costs if RQL does not take on these functions. This will form part of the proposed new license agreement for greyhound clubs similar to the Harness Licence agreement to be implemented from 1 January 2010.
 - (v) Confirm whether Harness sulky claims are approved going forward \$48K p/a.
 - (c) Approve the option below with the SOE to be leased and ensure 3 quotes are obtained in line with the RQL purchasing policy.
 - (i) New computer roll out IT equipment refresh project. All ex-GST.

The Board **APPROVED** the above recommendations except (v), the Board suggested that the sulky fund be removed in the near future but must be replaced with an alternative. The Board suggested that Mr Carter investigate what the New Zealand Harness Code has in place.

Mr Carter sought the Board's approval fro the draft FY1011 Budget Version 1.

The Board APPROVED the budget subject to the following changes:

- Cut the internal audit plan for FY1011 for only essential reviews such as payroll
- · Go to tender for internal audit
- · Look at employing an internal auditor
- The IT SOE guotes and tender to go to the next audit meeting for approval
- Redcliffe Harness Racing Club audit look at recouping the Deloitte audit fee of \$25,000
- Clarification in budget of what makes up the marketing expenditure
- Clarification of what the \$142K in Joint Venture Albion Park cost was for
- Committee and Board expenses in the Budget to be shown separately
- · Clarification if the Logan cost is in the Balance Sheet
- Look at the cost of the GAP Program as it may be getting too expensive

Mr Paul Brennan updated the Board in relation to Wagering and Racing YTD July 2010. See attached presentation.

This was **NOTED** by the Board.

Mr Paul Brennan updated the Board in relation to a number of initiatives currently being undertaken by the Product Development Department.

Club Licence Agreement

Mr Brennan sought the Board's approval to extend the existing harness and greyhound club licenses until 31 December 2010, to enable the development of a standard license agreement across the 3 codes.

This was APPROVED by the Board.

2.5 Integrity and Licensing Report - August 2010

Mr Jamie Orchard updated the Board in relation to the relevant issues in the Integrity Department.

Harness Racing - Chief Steward

Mr Orchard updated the Board in relation to the investigation outcome by Barrister Ms April Freeman into the allegation against the Harness Racing Chief Steward, Mr Martin Knibbs.

Ms Freeman found that Mr Knibbs did not take part in placing a bet as alleged and was not involved in the betting process, therefore there was no official misconduct. However, she did find that in putting himself in that situation, he has damaged his reputation and the reputation of RQL.

Mr Orchard met with Ms Susannah McAuliffe, who has outlined the following options:

- 1. Demotion of Mr Knibb's role, or
- 2. Mr Knibb's to be put on probation, or
- 3. No action to be taken by RQL, or
- 4. RQL to negotiate a separation package for Mr Knibbs

Mr Orchard suggested to the Board, through Mr Knibbs solicitor, RQL would negotiate the terms of a separation package or alternatively a probation period. Ms Murray informed the Board that the Crime and Misconduct Commission (CMC) would be closely monitoring on how RQL's deals with this situation.

Theft at Parklands

The CMC has referred the matter back to RQL for investigation. Mr Orchard informed the Board that the police are taking an active role in pursuing this investigation. Mr Orchard will keep the Board updated on the outcome.

Handicappers

The investigation into the Harness Handicappers has been finalised.

A complaint was received from Mr Arthur Harris concerning the Thoroughbred Handicappers, which was referred to the CMC. The CMC in the meantime has referred it back to RQL for investigation. Mr Orchard will keep the Board updated on the outcome.

Bowen Turf Club

Mr Cyril Vains has appealed to the Queensland Civil and Administrative Tribunal (QCAT) concerning his 3 months disqualification by the RQL Stewards. A date has not yet been set for the appeal to be heard.

Additional Sample Testing for Greyhounds

Mr Orchard sought the Board's approval to increase the number of samples taken from greyhounds during the 2010/11 year by 1000 samples at a cost of approximately \$50,000.

This was **APPROVED** by the Board.

3.1 Local Rules of Racing (Thoroughbred amendment)

Mr Orchard sought the Board's approval to amend the Local Rules of Racing 37(1) which provides as follows:

LR.37. Re-nomination if race abandoned or cancelled

- (1) Subject to the approval of Stewards and notwithstanding the provisions of AR111A, in the following instances a horse may be renominated for a Race Meeting for which the weights have been released but which the acceptance deadline has not expired:
- (a) a horse nominated for a race that was abandoned at closure of nominations; or
- (b) a horse balloted from a race at closure of acceptances; or
- (c) a horse accepted for a race that was abandoned at closure of acceptances; or

(d) a horse declared an emergency which was eliminated at the final scratching deadline.

This was APPROVED by the Board

- Page 7 change "thoroughbred" to "product"
- Page 10 change "RAT" to "QCAT". Also expand with the other codes
- Page 20 include employee rating, training and skills development.
- May/June 2011 for next employee staff survey

3.6 Redcliffe Harness Racing Club

Mr Orchard sought the Board to resolve the licensing status of the Redcliffe Peninsula Harness Racing and Sporting Club Inc (Club).

Mr Orchard recommended to the Board the following:

- Have an RQL Accountant to undertake a further review to identify all under remittances back to 1 September 2008
- Require payment to RQL by the Club of all outstanding amounts by 30 September 2010
- 3. Required the Club to provide by 30 September 2010 certification from their tax accountants that all contra deals have been properly recorded and reported in accordance with any applicable taxation legislation, and
- 4. Should the above steps be taken by 30 September 2010, reinstate the licence of the club from 1 October 2010 on condition that:
 - (a) All aspects of financial control and account preparation will be undertaken by RQL on behalf of the Club
 - (b) The Club must comply with any directions of RQL in respect of procedures and processes so that RQL can effectively carry out the functions referred to in (a), and
 - (c) All related party transactions (including any transactions, dealings or arrangements between the Club and its Committee members or their family members) must be fully disclosed to and approved by the Committee and must comply with any Statutory or RQL imposed requirements.

The Board RESOLVED that Mr Orchard put in place the above recommendations.


Key Points - July 2010



- Wagering Turnover for Greyhounds down 13.38% or \$735K with 2 less meetings held in FY1011 and 6 less meetings held at Ipswich in FY 1011
- Wagering Turnover for Harness down 2.68% or \$127K despite 3 more meetings being held in FY1011
- \$6.7M due to 5 more meetings being held in FY1011, with Wagering Turnover for Thoroughbreds up 18.26% or wet weather affecting July 2009
- Fixed odds activity has increased from 5% to 18% of overall wagering on QLD product through UNITAB

Wagering Turnover through TAB Clubs YTD July 2010







Wagering Turnover through TAB Operators YTD July 2010










Revenue return on QLD Racing Product
